1. On the afternoon of Friday, April 02, 2021 at approximately 2:00pm while walking down the northeast staircase from the third floor to the second floor in the Idaho State Capitol, I saw a young, white male standing on the north east side of the second-floor rotunda, next to the center bannister. He had a small camera set on the bannister and was standing in front of it and speaking to the camera. It was clear to me that he was making a video. He was

wearing black sweatpants a green colored sleeveless shirt and was armed with a holstered semiautomatic

- 2. As I stood there watching this individual, I was approached by an elderly lady who asked where the Governor's office was. As I pointed her in the right direction, I could not help but notice this young man had stopped what he was doing and was listening. As soon as the elderly lady walked towards the east wing, where the Governor's office is located, the young man with the gun picked up his camera, a black backpack type bag and headed in the
- 3. I followed and saw both enter the main doors to the Governor's office. I also entered but through the staff door located just west of the main doors. I stood by as the elderly lady spoke with Tamera Felter, the Governor's receptionist. As the young man stood there, he asked me if he could see the Governor. I told him he would have to speak with the receptionist. After Ms. Felter finished helping the elderly lady she began speaking with the young man. I listened while the young man explained to Ms. Felter that he wanted to interview the Governor to get his thoughts on persons convicted of felonies being able to carry guns. He went on to say that he was a felon and that by Idaho Code 18-310 he was able to carry a firearm and that he was trying to get the word out to others that they too could carry in Idaho. Ms. Felter asked him for his contact information. He told her his name was Jacob BERGQUIST and went on to say he was convicted of theft in Illinois. Before he departed, I asked why he was armed if he was a felon. He told me by Idaho code 18-310 he could and that I should check it out.
- 4. I contacted the Idaho State Police Regional Communications Center (RCC) and asked them to run a records check on Jacob BERGQUIST through Idaho and Illinois. RCC was able to find records on BERGQUIST through Illinois but nothing through Idaho. RCC was also able to provide me with a date of birth, 1993, as well as a picture from which I identified BERGQUIST. Ms. Felter had also gotten Mr. BERGQUIST's YouTube site, Guns and Rodents and sent me two videos of his visit to the Idaho State Capitol. The video's clearly show him in the Capitol and armed.
- 5. Based on the above information I respectfully request that the Ada County Prosecutor's office investigate potential charges against BERGQUIST for violation of Idaho Code 18-3316 and Idaho Code 18-310 (4).
