INDICTMENT

JAMES M. JOHNSON is accused by the Grand Jury of Ada County by this Indictment, of the crime(s) of: I. MURDER IN THE FIRST DEGREE, FELONY, I.C. §§18-4001, 4002, 4003(e) AND II. DESTRUCTION, ALTERATION, OR CONCEALMENT OF EVIDENCE, FELONY, I.C. §18-2603 committed as follows:

I.

That the defendant, JAMES M. JOHNSON, on or about the 10th day of December 2023, in the County of Ada, State of Idaho, did unlawfully and with malice aforethought, kill and murder Milo Warnock, a human being, by using force or violence upon Milo Warnock and/or by inflicting one or

more blunt force impacts and/or injuries upon Milo Warnock, from which Milo Warnock died, and where the defendant was incarcerated in a penal institution and Milo Warnock was an inmate at the same penal institution.


II.

That the defendant, James M. Johnson, on or about the 10th day of December 2023, in the County of Ada, State of Idaho, did willfully destroy, alter, or conceal blood and/or blood evidence by wiping the blood and/or blood evidence with a towel and/or otherwise attempting to clean up blood and/or blood evidence from the location where the defendant committed a murder, knowing that the blood and/or blood evidence was about to be produced, used, or discovered as evidence in a felony criminal investigation, and with the intent to prevent it from being so produced, used, or discovered.

All of which is contrary to the form, force and effect of the statute in such case made and provided and against the peace and dignity of the State of Idaho.
